The Honorable Randolph Baxter will retire from the Bench as Judge for the United States Bankruptcy Court, Northern District of Ohio at Cleveland, on August 15, 2011. This order provides for the administration of cases currently assigned to Judge Baxter and the assignment of newly-filed cases in Cleveland pending the swearing-in of a new Bankruptcy Judge.
