ORDER 20-03 TEMPORARY FILING PROCEDURES ON SEPTEMBER 30, 2021**

Ninth Amended General Order 20-03 Temporary Filing Procedures terminates on September 30, 2021. **Beginning October 1, 2021**, the use of the U.S. Mail to submit petitions and the court's temporary email address to submit filings at: [OHNB\\_Temporary\\_Intake@ohnb.uscourts.gov](mailto:OHNB_Temporary_Intake@ohnb.uscourts.gov) will no longer be permitted.

Registered Case Management/Electronic Case Filing (CM/ECF) users must continue to file electronically. Filers who are not represented by counsel and do not have access to CM/ECF may submit documents for filing through U.S. Mail\* or e-mail\*\* **through September 30, 2021**. Documents should be sent to the appropriate Court location address as follows:

**\*Through September 30, 2021**, all documents may be mailed by U.S. Mail. New case petitions must be received and/or postmarked through September 30, 2021. After September 30, 2021, all documents, **except new case petitions**, may be mailed by U.S. Mail by unrepresented persons.
